CEO report

New Logo roll out at Rec. Symposium scheduled for 4/30/2022. This will be at a low cost. Ric Logan assisted and found excellent resources. Now aligned with National Organization. About Logo-Bear forward moving, alert and strong, logos need to be trademarked. Need Lawyer to do this. Lots of work to get on tents, best material, etc.

Storeroom merchandise will be sold as much as possible or donated.

Renaming of League America for all Rec. Programs, may take some time to get used to.

Blane Shepard - Announced items to be covered for Recreational summit on April 30. Registration, train referee, etc. Everything will be recorded to be able to present at later times. There will be a Soccer Nation on July 31 at Dignity Field in Carson. Vendor booths, 7-8, 45 minutes sessions covering everything.

Terry Fisher

- We have hired Mr. Diogo Gama from Sporting to work with Hoffy.
- We want to be Technology leaders for Soccer.
- Never heard back from ITG.
- PPL, recruiting players to return appears to be rougher than planned. Comparing value to value. We have a few hundred teams.
- Soccer De Mayo in May at Bakersfield.
- Hired Juan Blanco to bring Latino teams to Cal South.
- We are now building trust.
- Robert mentioned how well Terry did with Pod Cast.

Roy mentioned the monthly referee meetings presented by Juan Guzman. He finds them interesting and exciting. Happy with mentoring. We need aggressive dealing when we encounter referee abuse/assault. No tolerance.

Terry gave updated referee count at 3306 registered referees. (900+ more awaiting final documentation).

Juan Guzman said he is listening to everything/everyone.

Committee reports

- NEC, Robert presented. Sunday, 4/3 is the end of the nomination period. Then we notify them and validate them. Working with Inspector of elections. Election ends on May 23, 2022, announce on May 24, 2022. To clear any questions, the current BOD is in place until this election is completed.
- Risk Management, by Christie. Had 2 hearings. Only one showed up with 2 more pending.
- PAD, Grant. Trending, only a few cases. Fewer cases in the last 6 months. Started working on streamline for PAD cases. Working with Juan and referees.
