IMPORTANT RISK MANAGEMENT UPDATE

Last month (June) we sent out a VIP communication which included several topics, one of which was the notification of a LiveScan update. We included the link to that new form. We now want to provide you with an urgent update regarding this process...

WHAT IS CalVECHS?

We needed to move to a new form because we are now under the CalVECHS program. What this program provides is an expanded safeguard for our children. **The previous LiveScan process only checked for arrests made within the State of California.** The CalVECHS program conducts a **national background check as well as provide for subsequent arrest notifications across the entire United States.** This ensures that any individual who committed a crime in the past within another state or does so moving forward, will be detected and Cal South will subsequently be notified.

Service Fees:

1. To help understand, the State Criminal Offender Record Information (CORI) fee is the amount for that State background report.
2. The "Rolling Fee" is what the servicer charges an individual to conduct the service of rolling their fingers on their device and

entering all the appropriate information into the system.

As a non-profit, Cal South clubs and members have always benefited from having a discounted State CORI Fee of \$0. The only fee needed to have been paid by the administrator was the servicer's Rolling Fee, which varies by location.

1. Now, under the CalVECHS program, there should be an additional fee of \$15 for that added federal background report.

What is the issue right now?

However, we were recently informed that the Department of Justice made the error of submitting Cal South as a "For Profit" organization under the new CalVECHS program. The result currently is that any admin who submits our form will be charged the "For Profit" State CORI fee of \$32 plus the Federal CORI Report fee of \$15 on top of the servicer's Rolling Fee. We have received reports some individuals have paid a total of \$80.

We have been working hard to get this error corrected within their system.

We suggest that you inform your admins to hold off on getting their LiveScan done for the time being temporarily until the error is corrected. Instead, please ask them to complete their other training compliances and leave the LiveScan as the last item to help clubs and individuals not incur that extra cost of \$32 for the State CORI fee.

At this moment we do not have a timeframe to share, however we will send out a notification as soon as we receive confirmation of that correction. We sincerely thank you in advance for your patience in the matter.
