

# IMPORTANT RISK MANAGEMENT UPDATE

Last week (July 10th) we sent out an Admin Update which featured important information regarding the new LIVEScan process named CalVECHS.

At the time of our announcement, we had been informed that the Department of Justice had made the error of submitting Cal South as a "For Profit" organization under the new CalVECHS program. This resulted in those submitting the form while we were listed as "For Profit" needing to pay higher fees than normal, sometimes as much as \$80 in total.

As of yesterday, July 15, Cal South is once again correctly listed as a "Non-Profit" organization by the Department of Justice within the CalVECHS program. Those going through the process now should only incur the Federal CORI Report fee of \$15 on top of the servicer's fingerprint "rolling fee" (which varies by servicer).

In case you missed the previous update, we will repeat the information about what CalVECHS is directly below...

## What Is CalVECHS?

We needed to move to a new form because we are now under the CalVECHS program. What this program provides is an expanded safeguard for our children. The previous LiveScan process only checked for arrests made <u>within</u> the State of California. The CalVECHS program conducts a national background check as well as provide for subsequent arrest notifications across the entire United States. This ensures that any individual who committed a crime in the past within another state or does so moving forward, will be detected and Cal South will subsequently be notified.

#### **Service Fees:**

- 1. To help understand, the State Criminal Offender Record Information (CORI) fee is the amount for that State background report.
- 2. The "Rolling Fee" is what the servicer charges an individual to conduct the service of rolling their fingers on their device and entering all the appropriate information into the system.

As a non-profit, Cal South clubs and members have always benefited from having a discounted State CORI Fee of \$0. The only fee needed to have been paid by the administrator was the servicer's Rolling Fee, which varies by location.


1. Now, under the CalVECHS program, there should be an additional fee of \$15 for that added federal background report.


### **New Cal South ID Template**

As previously mentioned on our updates, **you no longer need cardstock as you are able to use any white paper** to print your cards.

Instead under the **Team Roster** page, select **Print** in the bottom portion followed by **ID Card PDF** selection.





It is best to use color printers for this option since the logos will be included on the new ID layout.

**Note**: The "Print ID Card 8 per sheet or less" selection will be removed as an option after August 31, 2025.
